

PDM Digital Output MEMS Microphone Flex Evaluation Board User Guide

GENERAL DESCRIPTION

This user guide applies to the following MEMS microphone evaluation boards:

- EV ICS-41350-FX
- EV_ICS-41351-FX
- EV ICS-51360-FX
- EV_INMP421-FX
- EV INMP521-FX
- EV INMP522-FX
- EV INMP621-FX
- EV T3902-FX
- EV T5818-FX

This is a simple evaluation board that allows quick evaluation of the performance of PDM MEMS microphones. The small size and low profile of the flexible PCB enables direct placement of the microphone into a prototype or an existing design for an in situ evaluation. The evaluation board consists of a bottom port microphone soldered to a flexible PCB with color-coded wires attached. The only other component on the board is a 0.1µF supply bypass capacitor.

Table 1 describes the functions of the five connection wires. Table 2 describes the functional differences between the different microphones that are used with this flex circuit.






Figure 1. Evaluation Board Schematic




Figure 2. EV_ICS-41350-FX Board Layout (Top View)




Figure 4. EV_ICS-41351-FX Board Layout (Top View)




Figure 5. Bottom Port Evaluation Board




Figure 3. Bottom Port Mic Evaluation Board Layout (Top View)




Figure 6. Top Port Evaluation Board




Figure 9. EV_41351-FX Top View




Figure 8. Bottom Port Mic Top and Bottom View (All Others)
